- 2) Registration is open for Day #1 and Day #2 of the State CDE's. Most of the CDE's require qualification before entering. Ag Sales is reaching capacity. A few CDE's are open to all contestants without qualification. Please do NOT sign up on judging card for qualification events BEFORE your teams have made it. Registration found here
- 3) 4 of the 5 Regional CDE's have posted results and should be official soon. Use this document to see IF your team qualified. This document will be updated as more teams qualify.
- 4) Now is the time to secure transportation and <u>PARKING</u> Please do not drive a van or other vehicle to Madison Campus on April 25th and expect to find parking. Madison College has free parking for the CDE's on April 19th. Please work with UW Campus parking systems for oversized vans.

- 6) Check your judging card information to see that it reflects your CURRENT teachers and CORRECT advisors(s) email addresses. This is the MAIN way teams/advisors will be contacted. Wisconsin Association of FFA March Board of Directors Meeting Recap March 14, 2024 - Clarion Suites Hotel, Madison

- 1. State Officers provided a recap of events they participated in since the February Board Meeting.
- 2. Mrs. Zimmerman provided updates on current FFA membership now surpassing 25,000 but a number of chapters need to submit final membership. Leadership Conferences FIRE at SWTC-Fennimore 310 attended. Upcoming EDGE and Mission Conference registration is full and waiting lists have started. Mrs. Crook provided updates on American and State Degree submissions, proficiency awards, FFA band and chorus, LDEs and CDEs. The Board discussed concerns about needing more opportunities for members to participate in CDEs.
- 3. Updates were provided by Mrs. Ladsten, DPI; Mrs. Quinlan, Wisconsin FFA Foundation; and Mrs. Breunig, WAAE.
- 4. Henry Koerner Constitution/Bylaws and Policies Committee Report. Updates included membership extensions, hotel rooms at FFA Events, Star Finalist Interviews, State Officer Candidates, Gmail account policies, State Officer Information. It was discussed to make the policies more visible on the new website.
- 5. Linsey Mueller and Sally Ladsten presented the Finance Committee report. Mrs. Ladsten provided a full report on the proposed FFA budget which was approved by the Board. The Board voted to implement a per person fee for the 2024 State FFA Convention. \$20 per member and advisor which also includes the dance and games fee for Wednesday evening. There will be a \$10 fee for guests. This will exclude any special guests that have been invited including judges and sponsors.
- 6. Amber Bunnell and Parker Litterick shared the Membership Committee Report.
- 7. Julia Lenz and Lizzy Reinart shared the Awards and Programs Committee Report.
- 8. Jescey Thompson shared the Media and Public Relations Committee Report. Jescey was commended for the fantastic job done in leading the team with social media efforts throughout the year.
- 9. Amy Jentges and Sophie Koehler provided the Service Committee Report. FFA Jackets for the Blue Legacy program will be presented at state convention. Amy will be notifying advisors of recipients. SHP will be involved in the State Convention service projects to make 60 beds. Amelia Havden will serve as our Day of Service Co-Chair along with Tari Costello.
- 10. Brooke Wittrock and Mary Schrieber shared the Partners Committee Report.
- 11. Sectional LDEs were reviewed. Most Sectional LDEs have taken place. Holding rooms, quiz bowl questions, etc. were discussed.
- 12. Revised Section Realignment proposals were presented. A proposal was approved by the Board and will be sent to advisors and presented to the delegates at State FFA Convention.
- 13. The State Officer Task Force completed the new State Officer Handbook and State Officer Candidate application. The Board approved these items with several adjustments recommended from the state officers. Materials will be posted online. State Officer Candidate Academies will be held April 2, 10 and 16.
- 14. The Board was asked for any further recommendations for Honored Adult Recognition at State Convention.
- 15. Constitutional changes to the State FFA Degree Application were approved by the Board to move forward to the delegates at Convention.
- 16. The Board reviewed the LDE Task Force recommendations. There are many recommendations so further work will be done by smaller committees to make final recommendations.
- 17. The Wisconsin State Fair has asked the state officers to participate in the Ag Discovery Day April 30. We are also working with the State Fair to adjust the state officer work schedule in the Discovery Barnyard during the state fair.
- 18. The Onward Conference proposal was presented by Brooke Wittrock and Parker Litterick. It was approved by the Board to continue to explore the possibilities of offering this conference focused on career pathways. Mrs. Zimmerman will assign a steering committee.
- 19. Mrs. Crook shared the updates to the Safe Tractor Operators Contest Handbook. The Board approved the recommended changes with flexibility to make any additional changes needed.
- 20. Mrs. Zimmerman gave a State Convention update related to working with the Alliant Energy Center, provided assignments to state officer advisors and reviewed major schedule changes. Updates were also provided on the officers work with the sessions and reflections.
- 21. Mary Schrieber and Henry Koerner shared the updates to the Delegate Process for Wednesday June 12 at the State FFA Convention. Detailed information will be posted on the website and sent out to advisors. The Board approved the changes and the committees.
- 22. Julia Lenz reported on the Meals Committee as far as speakers invited and programs that will occur.
- 23. Linsey Mueller reported on workshops that are scheduled for convention and those individuals that have been invited to present workshops.
- 24. Amber Bunnell is working with the Past State Officer Committee.
- 25. Parker Litterick and Lizzy Reinart reported on the plans for decorations including recognizing state officer candidate and highlighting the 90th anniversary of the FFA jacket.
- 26. Brooke Wittrock reported on her work with the Seating and Courtesy Corp Committee.
- 27. Henry Koerner and Jescey Thompson reported on their work to create the "FFA Student Spotlight Stage" in Hall B on Wednesday.
- 28. Mrs. Zimmerman asked for the state officer advisors to provide her with their reservations for the Clarion Suites hotel.
- 29. The Board approved their recommendation to change the state degree ceremony by awarding recipients alphabetically by last name and not by section or chapter.
