## State Officer In-Person Visit/Event - COVID-19 Waiver

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. Due to its capacity to transmit from person-to-person through respiratory droplets, the CDC along with federal, state and local governments have set recommendations, guidelines, and some prohibitions which the Wisconsin Association of FFA adheres to. In consideration of a Wisconsin FFA Officer attending an event in person at your facility or hosted by your FFA Chapter, the undersigned acknowledge and agree to the following:

- We are aware of the existence of the risk of injury or illness such as, but not limited to Influenza, MRSA, or COVID-19 that may lead to paralysis or death, and verify that all participants in this event will follow all federal, state, and local guidelines to mitigate the risk of exposure.
- To the best of our knowledge, participants in this event have not experienced symptoms of fever, fatigue, difficulty in breathing, or dry cough or exhibiting any other symptoms relating to COVID-19 or any communicable disease within the last 14 days.
- To the best of our knowledge, participants in this event have not, nor any member(s) of their household, traveled by sea or by air, internationally within the past 30 days.
- To the best of our knowledge, participants in this event have not been, nor any member(s) of their household, diagnosed to be infected with COVID-19 virus within the last 30 days.
- If any participants in this event are involved in contact tracing, we agree to notify the Wisconsin FFA Center immediately to allow the state officer attending our event to adequately quarantine or isolate as necessary.

**Following the pronouncements above we hereby declare the following:**

- We are fully and personally responsible for the safety and actions of participants while and during participation in this event. Participants will be required to wear masks, social distance, and follow additional guidelines set forth by the host of the event. We recognize that participants may in any case be at risk of contracting COVID-19.
- With full knowledge of risks involved, I hereby release, waive, discharge the Wisconsin Association of FFA, Wisconsin FFA Center and other Wisconsin Team Ag Ed organizations, its board, officers, independent contractors, affiliates, employees, representatives, successors, and assigns from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death, that may be sustained by me or my personal network of family/ and friends related to COVID-19 while participating in any activity while in, on, or around the premises or while using facilities that may lead to unintentional exposure or harm due to COVID-19.
- I agree to indemnify, defend, and hold harmless the Wisconsin Association of FFA, Wisconsin FFA Center and other Wisconsin Team Ag Ed organizations from and against any and all costs, expenses, damages, lawsuits, and/or liabilities or claims arising whether directly or indirectly from or related to any and all claims made by or against any of the released party due to injury, loss, or death from or related to COVID-19.

By signing below, I acknowledge that I verify that I fully understand, agree to and accept all provisions and obligations set forth in this waiver. This waiver will remain effective until guidelines and mandates relevant to COVID-19 are revised and/or lifted.
